Phthalates

A group of chemicals that can Used preservative in make products (usually plastics) softer and more flexible. They are sometimes called plasticizers, though there are many other types of plasticizers too.

Parabens

cosmetics. Detected in human breast cancer tissues, suggesting a possible association between parabens in cosmetics and cancer.

Sulfates

Makes products bubble and foam, yet has been classified as a possible developmental toxicant based on evidence that it may interfere with human development.





Mineral Oil

Petroleum by-product that coats the skin like plastic, clogging the pores. Interferes with skin's ability to eliminate toxins, promoting acne and other disorders

Nitrosating Agents

The following chemicals can cause nitrosamine contamination, which have been determined to form cancer in laboratory animals. There are wide and repeated concerns in the USA and Europe about the contamination of cosmetics products with nitrosamines.





BHA and BHT

The International Agency for Research on Cancer classifies it as a possible human carcinogen. The European Commission on Endocrine Disruption has listed BHA as a Category 1 priority substance, based on evidence that it interferes with hormone function

PEGs (polyethylene glycols)

Used as cosmetic cream bases. PEG compounds themselves show some evidence of genotoxicity, and if used on broken skin can cause irritation and systemic toxicity.
